Server/Database of adequate size and specifications for storing and accessing survey reports of all locations till the contract period. The time period may be extended by IHMCL and contractor shall make necessary arrangements accordingly.viii. Contractor shall make minimum 20 user id and passwords for IHMCL for remotely accessing the reports from web based system.ix. The service provider may setup his own Web Server or take services from external source.x. The service provider shall ensure security of survey data for a period of 6 months from the acceptance of final reports and Data. Also, shall have data backup and disaster recovery mechanism as per best industry practices.xi. IHMCL shall be the owner of the data and the Service Provider shall not use such data for any purpose and will hand over all data related to survey including Reports, videos (Hard copies & Electronic form) to the IHMCL after the expiry of the contract period.
